Important Highlights of Series Rules pertaining to the Show:

- To participate, shows must complete this form. The \$100 Sanctioning Fee is no longer required.
- To eliminate duplicate judges, we ask that you work with us by notifying us before/after you have selected a judge. Make sure to ask the potential judge if they have accepted any other MCLB sanctioned shows before asking them to judge your show to avoid duplicates.
- Please email us a flier of your show, or a link to the flier as soon as it is available. We ask that you promote our series in any way possible and we will do the same to advertise your sanctioned show.
- We ask that you allow our corporate sponsor to set up a booth at your show if they wish to promote their products.
- Any showman 21 years of age or under as of January 1 of the current year can exhibit.
- Classes will be broken out by weight – all shows must hold a weigh-in prior to the show. **Declared weights are not allowed.**
- AFTER THE SHOW:
 - **Send a list of the classes that includes showman's name, scrapie tag number of the animal, and placing in the class.** A copy of the classes with placings listed out to the side of the class breaks works great. *Note: we need market, wether dam & showmanship results.*

DIVISIONS REQUIRED TO BE OFFERED:

● **Wether Dam Show**

- Both ewe lambs and yearling wether dams are eligible.
- Ewe Lambs are shown by weight, yearlings will show in a single yearling class.
- ****NEW:** We have merged the WBI (white-face breed influenced) division into the wether dam division. There will be a separate breed division of WFX (white-faced cross) wether dams shown at the beginning of the wether dam division. The **TOP 3** WFX will be selected, and they will be shown for champion overall wether dam.
- All classes must be placed top to bottom
- **WETHER DAM CLASSES NEED TO CONSIST OF 4-6 HEAD for points purposes.**
- **WE NEED A TOP 5 OVERALL WETHER DAM LINE-UP**

● **Market Lamb Show**

- All market lambs can be ewes or wethers and must have lamb teeth
- Market lambs are shown by weight.
- ****NEW:** We have merged the WBI (white-face breed influenced) division into the market division. There will be a separate breed division of WFX (white-faced cross) market lambs shown at the beginning of the market lamb division. The **TOP 3** WFX will be selected, and they will be shown for champion overall market lamb.
- All classes must be placed from top to bottom
- **MARKET CLASSES NEED TO CONSIST OF 4-6 HEAD for points purposes.**
- **WE NEED A TOP 5 OVERALL MARKET LAMB LINE-UP**

● **WBI (White-Faced Breed Influenced) Show (white faced and speckled lambs)**

- NO LONGER A SEPARATE DIVISION – WETHER DAMS AND MARKET LAMBS WILL BE SHOWN IN THEIR CORRESPONDING DIVISIONS UNDER A SEPARATE BREED DIVISION – WFX WETHER DAMS AND WFX MARKET LAMBS.

● **Showmanship Show**

- **Divided into 3 Divisions: JUNIOR- 10 & Under; INTERMEDIATE (11-14) and SENIOR- 15 & over (as of Jan 1).**
- **WE MUST HAVE A TOP TEN OVERALL FOR EACH AGE DIVISION (unless less than 10 Participate).** If you need to have “heats” for showmanship because of large class sizes, that is fine, just make sure to get us a list of ALL of the participants - even the ones that didn’t make the top 10.
